PART 1. GENERAL

1.1 COMPETITIVE COST SEALED BIDS

Sealed bids for construction of **New Deep Well & Chemical Treatment Building** will be received until **December 17, 2024 at 1:30 P.M. local time** at the City of Byron, located at 401 Main Street, Byron, GA 31008, at which time they will be publicly opened and read. **Any Bid received after said time and date will not be considered by the Owner.** No bid may be withdrawn after the closing time for the receipt of bids for a period of sixty (60) days except as specifically provided in the Instructions to Bidders and/or by State Law.

1.2 SCOPE OF WORK

The work to be done shall consist of furnishing all materials and equipment and to perform all labor necessary to construct the deep well, install a 1,200 gpm vertical turbine well pump, and associated chemical feed buildings as shown in the Drawings and specified herein. Work shall include, but not be limited to, a new deep well and 1,200 gpm vertical turbine well pump, masonry chemical feed building, FRP chemical feed building, chemical feed systems, instrumentation, electrical, and SCADA. Work also includes site work, concrete and asphalt paving, yard piping, fencing, painting, erosion and sediment control measures, NPDES monitoring, grassing, construction staking, mobilization/demobilization, bonds, insurance, delivery of materials, taxes, and all other appurtenances necessary for completion of the work as shown on the Drawings and as specified in the Contract Documents.

Time allotted for completion of work is **420 calendar days** from the date of a written "Notice to Proceed" from Owner. All Work shall be completed in accordance with the plans and specifications. The Work, if awarded, will be awarded in **one** (1) **Contract.**

1.5 CONTRACTOR LICENSE

Therefore, the Contractor submitting a bid must list the license number of the Contractor performing the utility contracting on the bid form and provide proof of a valid license. Performance and Payment Bonds, each in an amount equal to 100% of the contract price shall be required of the successful bidder if contract is awarded. Each Bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond.
